

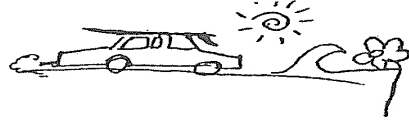

This liability includes the loss of the use of the car to **Manaloa Rent A Car**. If you accept CDW, you may be responsible for damage under certain prohibited events. Read this rental agreement. 1) Car to be returned clean and no garbage, if returned dirty and with garbage 30\$ fee will be applied 2) Flat tires caused by road hazards are the renter's responsibility. 3) If vehicle overheats, renter must turn it off and call immediately MRAC, failure to do so will make customer liable for repair costs 4) Parking tickets are the renter's responsibility. We encourage you to pay them immediately, if you don't pay we will pay the fine plus \$50 handling charge 5) Vehicle is not to be operated on Highway 31 from Hana to Ulupalakua. If the car breaks down, is stranded or requires towing on that part of the highway, renter assume full responsibility for all towing and repairing cost 6) Broken glass, unless caused by an accident with another vehicle at fault, is the responsibility of the renter. 7) Unauthorized airport drop offs incur \$100 charge 8) Vehicle to be returned to specified location by date and time specified. There is no grace period on vehicle return. Any vehicle returned after the indicated time will be charged to renter at the maximum daily rate. 9) Absolutely no refunds, except for repeated mechanical failure 10) This contract is subject to final audit and charges by owner. 11) Only persons listed on the agreement of otherwise authorized by law and above the age of 21 may drive this vehicle. You are responsible for all collision damage to the vehicle even if someone else causes it or the cause is unknown. You are responsible for the cost of repair up to the value of the vehicle. You must return the vehicle to the same location in which it was rented on or before the indicated time due back time. There will be additional charges if the vehicle is not returned as specified. Where permitted by law, which it was rented unless otherwise noted above, on or before the indicated due date. There will be a \$20.00 per check charge for all returned checks. I authorize you to process a credit card voucher in my name for all charges including the retail fair market value of any vehicles not returned to **Manaloa Rent A Car**, all fines, towing, booting expenses, court costs, penalties, forfeitures or administrative fees the MRC incur for parking, traffic, and other violations incurred by me during the rental period, and to apply payments towards charges in whatever order MRC deem necessary. My signature below is considered made on the applicable credit card voucher. Renter understands that renter's car insurance and other applicable insurance coverage shall be primary, and, subject to Hawaii law, **Manaloa Rent A Car** liability insurance is secondary.
